A replacement packet can be mailed or emailed to them and their questions will be answered or directed to a DCC&R Revisions Committee member.
4. Finally, be sure to share the information that ***everyone who returns their completed Requests for Approval asap will be eligible for cash drawings in February, March, April and May.***
