## Title: Men's Golf Association Events

### 1. OBJECTIVE:

To establish guidelines for members and guests who participate in the SVR Men's Golf association (SVRMGA) sponsored events.

### 2. POLICY:

- 2.1 Members of the Star Valley Ranch Men's Golf Association (SVRMGA), who are over 18 years of age, and who have paid all current Star Valley Ranch Association Property assessments (when applicable) and SVRMGA membership Dues and are currently a member of USGA will be eligible to participate in SVRMGA sponsored events
- 2.2 Members in compliance with (1.), above, may also have guests participate who are over 18 years old and are accompanied by an Association member. Guests will not be eligible for tournament prizes.
- 2.3 All players are responsible for their own green fees.
- 2.4 USGA rules shall apply to all applicable events. Special local **(POSTED)** home course or events rules may apply and shall be defined by the Pro or tournament chairman.
- 2.5 Only USGA handicaps shall be used. New members who have not yet established handicaps shall contact the SVRMGA handicap chairman to determine initial handicap. Players are responsible for assuring that their scores are adjusted and have been posted correctly for each "postable" event.
- 2.6 Members of the SVRMGA have the responsibility to inform the **SVRMGA** Board of Directors of any witnessed USGA rules infractions observed during SVRMGA sponsored events.
- 2.7 Each member is responsible to sign up for the events in which he wishes to participate. When a member is unable to play in an event for which he has signed up, he shall call and cancel as early as practicable. "No Shows" or cancellations within 24 hours, tournament fees will not be refunded.
- 2.8 All SVRMGA events will be under the direction and coordination of the SVRMGA Vice President (this includes the Men's and Women's Tuesday Mixer). Any formatting, prize distributions, event rules or problems affecting the event will be administered by him.

2.9 The round robin event points requirements at the beginning of the season shall be as follows:

a) For players who have established points from a previous playing year at Cedar Creek, the points to be made shall be the points required after the last time he played.

b) For players who have an established USGA handicap, no older than one year, the initial points required shall be his handicap subtracted from 36.

c) For players who do not fall into either above categories, the points to be made shall be the points he actually does make on his first day of play. (He will not help nor hinder his team.) After his first day, his points to be made shall be calculated in the usual way.

This Policy has been reviewed and approved by the SVRMGA Board of directors, and becomes effective on the following date.
