Title: SVRA Championship

## 1. Objective:

To provide direction for the Star Valley Ranch Men's Golf Association (SVRMGA) annual Championship. This tournament is a two day, 36-hole event, low gross, low net event flighted by course handicap into flights as determined by the Star Valley Ranch Association club professional (club pro) and Tournament Director based on the number of SVRMGA participants.

## 2. Policy:

- 2.1 ELEGIBILITY: All current members meeting the membership requirements established in Policy 001, Paragraph 2.1 will be eligible to participate in the tournament.
- 2.2 REQUIREMENTS: Participants must have played in and posted scores for a minimum of five full 18 hole SVRMGA events, played after the previous year's Club Championship. Exceptions to the above may be approved by the SVRMGA board of directors. Requests for exception must be submitted 30 days prior to the tournament for consideration
- 2.3 ENTRY FEES: Entry fees shall be established by the SVRMGA Board of Directors prior to the tournament play.
- 2.4 FLIGHTS: The Club Professional will flight the tournament by course handicap. Numbers will be balanced to equalize each flight.

## Example:

Handicap 0-15 Flight One Handicap 16-24 Flight Two Handicap 25-Up Flight Three

- 2.5 Pairings for the first round will be according to the course handicaps within that flight.
  - The second round pairings will be by the gross scores from round one.
- 2.6 AWARDS: Amount of prize money shall be established by the SVRMGA Board of Directors prior to the championship play. The amount of payout will be determined by the number of players.

CLUB CHAMPION: Low Gross Player for 36 Holes regardless of flight

PRESIDENTS CUP: LOW NET CHAMPION: Low net score for 36 holes regardless of flight

LOW GROSS AND LOW NET Awards for each flight will also be given If you win Low Gross you will not be eligible for a Low Net award.

- 2.7 Ties for the championship awards shall be determined by a sudden death play-off starting on hole number one
- 2.8 THIS SECTION HAS BEEN DELETED BY THIS REVISION. Previous Policy stated that the club elections to be held at a dinner after the Club Championship. Elections are now held after the Choke Cherry in September
- 2.9 The SVRMGA directors shall be responsible to update the Club Championship and President Cup plaques in the Cedar Creek facility foyer after the Club Championship. The SVRMGA treasurer shall provide funds from the treasury for the engraving.
