## Call to order:

## Agenda:

The agenda of the meeting was to review banking, end of year reconciliations, team salaries and the promotion of Heather Bigelow to the position of Assistant General Manager.

Keri Sawdy, General Manager presented the business at hand to which the Wells Fargo CD was maturing on January 2, 2025 with an interest payment of \$9,500.00. The reinvestment was presented to the Board that another 12-month CD, non-callable with monthly interest payments should be purchased. The Board decided to have General Manager Sawdy make inquires at the time of the CD maturity for the best interest rate and to then present the same to the Board of Directors for a vote.

With regards to the 2024 End of Year Operating Account Reconciliation, General Manager Sawdy presented the financials along with the appropriate credit and debits to reconcile the account as per the Fiscal Year End Operating Policy. The Directors reviewed recommended financial transfers and the respective banking accounts needed to delineate assessment and golf income funds. Team salary increases for 2025 were proposed by way of surplus golf course revenue from 2024. The proposed increases would then become the base salaries for 2026. The Directors voted as follows:
